GENERAL CONTRACT CONDITIONS

Object. These general conditions regulate the contract for accommodation services on a full board basis at the Host School provided by NOVASCHOOL MEDINA ELVIRA, S.L. with registered office in Atarfe (Granada), Club de Golf Building, Medina Elvira Golf Residencial Urbanization, and CIF B-19654995.

Acceptance of general conditions. By contracting our services, the contracting party expressly states that he or she has read, understood and accepts without reservation these general conditions, as well as any specific conditions that may be established. All general conditions will be permanently available to Users prior to contracting and may be stored and reproduced and printed in the version in force at any time. These conditions will have an indefinite period of validity, with NOVASCHOOL reserving the right to modify them unilaterally, without this affecting the services that were contracted prior to the modification, with those that appear published on the website at any time being understood to be valid.

Recipients of the services. The users who can contract the accommodation services offered will be SCHOOL CENTERS OR COMPANIES that offer educational services to schools.

Hired services. The contracted services and prices are those detailed according to the budget sent and accepted. In the event that the number of students is increased, the budget will be increased by the amount in euros (€) per student detailed, and always conditioned on availability in accordance with the maximum accommodation capacity of the Host School.

Rules and regulations of internal regime and operation. The contracting center accepts the INTERNAL REGIME AND OPERATION REGULATIONS that regulate the coexistence of residents and the use of the common parts of the building. The contracting center is obliged to comply, without any restriction or reservation, with the rules contemplated in the Internal Regime Regulations of Novaschool Medina Elvira and the different rules for the use of common spaces, the Internet, and the devices or utensils made available to the student and resident in general, both in the contracted accommodation and in the common areas, with the contracting entity committing to communicate this commitment personally to each resident/student.

Below is the set of essential rules to reside in the Novaschool Host School, which are mandatory without any restriction or reservation, the rules contemplated in this Internal Regime Regulation of the Novaschool Host School and the different rules for the use of the common spaces, the internet, and the devices or utensils made available to the student and resident in general, both in the contracted accommodation and in the common areas, THE SCHOOL OR COMPANY that contracts the services undertakes to communicate this commitment personally to each student.

BEDROOMS. Each student will be assigned a shared room, which may be triple or quadruple, with the person most responsible for it and having to take into account:

- Order: Students must keep the rooms clean and tidy.
- Damage: The students who own the room are responsible for damage to the furniture and architecture, and cannot avoid such behavior towards other classmates. The value of the damage will be charged to account.
- The students will try to live in the order that coexistence requires and will properly take care of the Novaschool Host School, its furniture, objects and facilities.

DINING ROOM. Meals will be served in the dining room (on the ground floor) by the kitchen staff or in a picnic format as contracted. The schedules will be those agreed upon between the Host School and THE SCHOOL OR COMPANY that contracts the services upon signing the contract and booking the services. Without prior notice or justification, no exceptions will be made to meal times. In the event that a student suffers from a chronic illness or condition that forces him or her to maintain a special diet, or to eat without salt or sugar, etc.; THE SCHOOL OR COMPANY that contracts the services to Novaschool must be informed at least 7 days before the start of the service.

VALUABLE OBJECTS AND MONEY. Valuable objects or money should not be stored in the room; their loss will be the responsibility of the owner. The Host School has a box to guard and manage them.

BED SERVICE. The rooms include bed service and will be changed weekly for stays longer than 7 days. The student must bring his/her bathing supplies and towel and whatever he/she needs.

MOBILES/ELECTRONIC DEVICES. The Management reserves the right to prohibit or limit the use of electrical devices in the rooms, if this harms the environment of the Novaschool Host School, the silence, order, or safety of the electrical installation. The use of heaters, television, etc. is totally prohibited.

ASSISTANCE AND PUNCTUALITY. Students must comply with the schedule established for their group and agreed with THE SCHOOL OR COMPANY that contracts the services, both for waking up and for the contracted activities, meals, sports hours, etc.

ALCOHOL AND/OR DRUGS. The possession and consumption of any type of drugs and alcoholic beverages is absolutely prohibited within the Host School. FAILURE TO COMPLY WITH THIS CONDITION IS GROUND FOR IMMEDIATE EXPULSION. The expulsion will be carried out by preventing the student from accessing the Host School and its facilities, except to remove their clothing and personal effects, which, if not removed, will be made available to the students, keeping them for a period of three months, after which, without having been removed, can be destroyed or donated.

Access to the Host School is prohibited to any person outside it, unless expressly authorized by the Management.

Cancellation of service. In case of cancellation of the service, total or partial, Novaschool Medina Elvira will penalize the contracting entity with a 10% cancellation fee on the amount of the canceled budget. In case of no-show or cancellation after 72 hours before the start of the service, Novaschool Medina Elvira will apply a penalty for cancellation of the additional 20%. If the contracted service includes carrying out external activities such as visiting the Alhambra, Science Park, Club Náutico Cubillas, Aventura Entrepinos, Caves Windows, Oasys Mini Hollywood, etc. The penalty will be increased according to the return or cancellation rules of each external entity.

Way to pay. Transfer of 100% of the amount and the contracted service upon signing the quote. The account number where the deposits must be made is **ES76 0128 0780 5101 0014 5174 (Bankinter) and SWIFT CODE (BIC): BKBKESMMXXX.** The invoice will be issued and sent to the contractor upon completion of the contracted service.

Contract resolution. Failure to comply with any of the sections expressed above will be a termination clause of this contract.

Other provisions. The School Center or Company that contracts accommodation services must have:

- Contracting of liability insurance.
- Contracting of accident insurance for all residents.
- Assume the obligation to care for the facilities and be responsible for the proper use made of them.

Responsibility. THE SCHOOL OR COMPANY will be responsible for all damages that may be caused by students or residents during the period of stay in the Host School due to misuse of the facilities or furniture of the Host School. At the end of the service, Novaschool will carry out a review of all the rooms and facilities and if any incident is detected, it will issue an incident report and will proceed to notify those responsible for the SCHOOL OR COMPANY that hires their services.

THE SCHOOL OR COMPANY that contracts the services must have liability insurance that covers all damages due to misuse of the Novaschool Host School and its facilities that may be caused by students or residents.

In the event that, for any reason, the Insurance does not cover the damages caused, the school or company contracting the services will be directly responsible for them.

In the event that the SCHOOL OR COMPANY that contracts the services does not provide said liability insurance 72 hours before the start of the service, it must deposit a deposit of €30 per student, which must also be deposited. 72 hours before the start of the service. The deposit will be returned at the end of the stay and after reviewing each of the rooms and only in the event that there is damage, Novaschool will not return the deposit in the amount that is sufficient to cover the damages caused. Likewise, if the damage is greater than the deposit deposited by the SCHOOL OR COMPANY that contracts the service, Novaschool will send a quote with the amount of the repair so that the SCHOOL OR COMPANY that contracts the services can make the corresponding payment.

Data Protection. The provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April, relating to the protection of natural persons with regard to the processing of personal data and the free circulation of this data and repealing Directive 95/46/EC (General Data Protection Regulation), as well as such as Organic Law 3/2018, of December 5, on the Protection of Personal Data and guarantee of digital rights. The parties undertake to maintain confidentiality with respect to personal data, diligently fulfilling the duty of care and custody, committing to adopt the necessary technical and organizational measures that guarantee the security of the personal data held. access and to avoid unauthorized alteration, processing, loss and access. NOVASCHOOL MEDINA ELVIRA S.L as Data Processor, and its staff, will only process the data within the framework of the services it offers and only in accordance with the instructions received from the contracting entity, excluding, in any case, any use for its own purposes or for statistical purposes. To this end, Novaschool Medina Elvira S.L will only allow access to personal data to those employees who are necessary for the provision of services to the school.

Statement. I have read and accept the terms and conditions of this quote, and the accompanying documents.
