INTEGRATION to "Pact of educational co-responsibility"

APPROVED BY RESOLUTION OF THE SCHOOL BOARD MEETING OF 09/04/2020

The complexity of the present moment and the lack of certainty about the possible future development of the SARS-COV-2 pandemic calls for a common reflection on strategies and initiatives suitable for the organization of a safe start of the new school year.

This document it is intended to integrate the Educational Covenant of Co-responsibility with the commitment of families, parental authority holders or adult students to respect and strengthen the educational alliance between school, family and students.

The School-family Educational Covenant of Co-responsibility(document provided for by Presidential Decree 235/07 and subsequent regulations), with the new integration relating to protection from biological risk SARS-COV-2, as indicated in the Technical Document of the CTS n. 28, as well as being a pedagogical document of school-sharing of educational intent, is also a document of a contractual nature and therefore its signature is required by each parent in order to assume mutual commitments.

SEEN the Memorandum of Understanding to ensure the start of the school year in compliance with the safety rules for limiting the spread of SARS-COV-2 of 6 August 2020;

VIEWS the Guidelines and Notes on limiting the spread of SARS-COV-2 in the school environment and the safe start of the school year 2020/2021 issued by the Technical-Scientific Committee and by the various Regional School Offices;

SEEN the Institute's DVR and its additions;

THE FOLLOWING INTEGRATION IS SIGNED TO THE CO-RESPONSIBILITY EDUCATIONAL AGREEMENT:

The School Institution is committed to:

- implement all the organisational measures, within the limits of its own competences and with the available resources, in compliance with the regulations in force of the guidelines issued by the Ministry of Health, the Technical and Scientific Committee and other competent authorities, aimed at mitigating the risk of spreading SARS-CoV-2;
- 2. adopt a specific return plan, consistent with the characteristics of the context;
- 3. guarantee safety and hygiene conditions in all environments dedicated to school activities;
- 4. organise and implement informational actions aimed at the entire school community and staff training for the prevention of SARS-CoV-2 infection;
- undertake training and retraining courses for school staff on digital skills in order to implement and consolidate effective teaching practices with the use of new technologies, also useful in times of health emergencies, to support students' and students' learning;

- 6. guarantee the safe provision of training, providing in line with the school's environmental and organisational conditions, and in agreement with the competent authorities also the use of distance learning, if necessary;
- 7. strictly and scrupulously comply, in the case of a confirmed Covid-19 infection by a pupil or adult attending the facility, with all provisions of the local health authority and with the provisions of IIS document no. 58/2020 of 21 August 2020 "Operational guidelines for the management of cases and outbreaks of SARS-CoV-2 in schools and childcare services";
- 8. ensure transparency in administrative acts, clarity and timeliness in communications, including through the use of IT tools, guaranteeing respect for privacy;
- 9. monitor the correct application of rules of conduct, regulations and prohibitions, consistently with the measures adopted by the competent authorities;
- 10. to behave with diligence, prudence or expertise in compliance with the rules, the Institute's indications and scientific recommendations, in order to prevent the spread of the virus and exposure to danger to one's own health and that of the school community.

The family is committed to:

- 1. to view the Plan for the management of the health emergency from SARS-COV-2, guaranteeing its application for the part of its competence (with particular reference to its rights and duties in terms of individual and collective health);
- 2. to examine the Institute's Regulations for Integrated Digital Teaching and to be constantly informed about the initiatives undertaken by the school on the subject;
- 3. share and support the School's indications, in an atmosphere of positive collaboration, in order to guarantee the safe conduct of all school activities;
- 4. make sure that their children carry out all school activities correctly, both in presence and at a distance, and that they respect the rules of use (in particular with regard to security and privacy and respect for netiquette) of the web and the technological tools used in carrying out distance teaching activities, as per the Google Suite and netiquette regulations published on the school website;
- 5. actively participate in the life of the school, regularly consulting the website and the electronic register;
- 6. monitor the state of health of their daughters, sons and other family members systematically and daily, and in case of symptoms related to SARS-COV-2 (fever over 37.5°C, chills, dry cough, tiredness, soreness, muscle aches, diarrhoea, loss of taste and/or smell, breathing difficulties or shortness of breath), keep them at home and immediately inform their family doctor or doctor's office following the instructions and instructions;
- 7. ensure that their children's timetables for entering and leaving school and attending school are respected, both in presence and from a distance;
- 8. go immediately to school and pick up the student in the event of a sudden manifestation of symptoms related to SARS-COV-2 in compliance with the Regulations on measures to prevent and contain the spread of SARS-COV-2 in the Institute, ensuring that a family member or a person in charge is constantly on call during school hours;
- 9. collaborate, in the event of a positive diagnosis of SARS-COV-2 by their daughter or son, with the School Manager, his or her First Helper or the teacher identified as the Covid contact person, and with the Prevention Department of the Local Health Authority to allow monitoring based on the tracking of close contacts in order to identify possible other cases at an early stage;
- 10. contribute to the development of the personal autonomy and sense of responsibility of students in order to promote correct behaviour towards the measures adopted in any area to prevent and combat the spread of the virus, including the punctual observance of the entry, exit and school attendance times

- of their children to teaching activities both in attendance and at a distance and the respect of the rules relating to integrated digital teaching;
- 11. behave with diligence, prudence or expertise in compliance with the rules, the Institute's instructions and scientific recommendations, in order to prevent the spread of the virus and exposure to danger to their own health and that of the school community.

Students and families are committed to:

- comply with all rules of conduct, regulations and prohibitions defined by the
 competent authorities and the Institute, with particular reference to the daily
 measurement of temperature before moving to school, distance between people,
 use of protective devices (e.g. masks etc.), personal hygiene / disinfection,
 compliance with any prescriptions/differentiations during school hours, specific
 methods of entry/exit from the school facility;
- collaborate actively and responsibly with teachers, other school workers, school
 mates and companions, in the context of presence and distance learning
 activities, i.e. with the help of digital platforms, undertaken for the health
 emergency, in compliance with everyone's right to learn and with the Institute's
 regulations;
- carry out all school activities correctly, guarantee attention and active participation both in attendance and at a distance, according to the indications provided;
- respect the rules of use (in particular security and privacy) of the web network and of the technological tools used in the possible performance of distance learning activities, as per the Google Suite and netiquette regulations published on the school website;
- 5. transmit/share all communications coming from the School with their relatives/guardians;
- behave with diligence, prudence or expertise in compliance with the rules, the Institute's instructions and scientific recommendations, in order to prevent the spread of the virus and the exposure to health risk of the school and the school community.

Students and families also undertake to comply with the following conditions:

The "preconditions" for the presence of pupils at school are:

- 1. the absence of respiratory symptoms or body temperature above 37.5° C even during the previous three days;
- 2. not having been in quarantine or isolation at home in the last 14 days;
- 3. have not been in contact with positive people, to the best of their knowledge, in the last 14 days.

Anyone with respiratory symptoms or temperature above 37.5° C must stay at home and not enter the school.

Please refer, therefore, to the individual responsibility for the state of health of children entrusted to parental responsibility.
