1. Introduction

This agreement sets out the terms and conditions on which the Training Provider will provide the training course to the Client.

2. Course Details

The Training Provider will provide the Client with the training course described in the course outline ("Course Outline"). The Course Outline may be amended by the Training Provider from time to time in consultation with the Client.

3. Course Fees

Within 10 days of receipt of the registration confirmation, the sending organisation must pay 30% of the total course fee. The balance must be paid 4 weeks prior to the start of the course.

If participants are registered less than 4 weeks before the start of the course, the total course fee must be paid no later than 10 days after receipt of the registration confirmation.

Only bank transfer payments are allowed, no cash payments. The invoice with bank details will be sent to you along with the Course Confirmation Document.

4. Course Cancellation and Refunds

Cancellations must be submitted via email. For cancellations made more than 4 weeks before the start of the course, the Training Provider will refund the full amount minus 30% of the total. For cancellations made less than 15 days before the start of the course, the Training Provider reserves the right to retain the full cost of course and accommodation (if required).



5. Training Provider's Rights

The Training Provider reserves the right to:

- (a) change the format, content and/or timing of the course;
- (b) change the Training Providers who deliver the course; and
- (c) cancel or reschedule the course.

6. Client's Rights

If the Training Provider cancels or reschedules the course, the Client will be entitled to a full refund of the course fees paid.

7. Intellectual Property

The Training Provider retains all intellectual property rights in relation to the course material. The Client is permitted to use the course material for their own personal use only and may not copy, reproduce or distribute the course material without the prior written consent of the Training Provider.

8. Confidentiality

The Client must keep confidential all information which is of a confidential nature and relates to the business or affairs of the Training Provider ("Confidential Information"). 10. Liability

- (f) This agreement is not intended to be for the benefit of, and may not be enforceable by, any person other than the parties to this agreement.
