Small-scale partnership in school education project with multiple beneficiaries under the ERASMUS+ Programme - Grant agreement number- 2021-2-RO01-KA210-SCH-000048099

The purpose of this Partnership Agreement is to provide a framework for cooperation based on mutual trust between the two partner organizations for the successful implementation of all **Green Bridge for Future** project activities.

Following the approval of the project entitled **Green bridge for future** (hereinafter referred to as "the Project") under the Erasmus + Program, Key Action 2 - Partnerships for Cooperation, reference number 2021-2-RO01-KA210-SCH-000048099 and by signing the contract by the Coordinator by mandate from the other Beneficiaries (partner organizations), all beneficiaries accept the funding and agree to carry out the Project, assuming full responsibility for its implementation.

The project will be implemented throughout 18 months in between 14/03/2022 and 13/09/2023, the period in which students and teachers from partner schools will be involved in local and transnational activities; transnational mobility activities taking place as follows:

- October 2-8, 2022 - Italy
- March 26-April 1, 2023 - Romania
- May 7-13, 2023 - Turkey

Funding will be a maximum of 60,000 € of which 16,740 € will go to the partner organization Istituto Comprensivo „D.Bramante ”.

Scoala Gimnaziala nr. 1 Rosia will make the following payments to the Istituto Comprensivo „D.Bramante ”: 80% of 16,740 €, ie 13,392 € in three installments as follows:

- April 2022 – 3600 € for management activities
- September 2022 - 6272 €- individual support – for the hosted mobility
- January 2023 - 3520 € transport support for 12 students and 4 teachers

Following that the remaining 20% will be transferred after the payment of the balance, after the end of the project.

Scoala Gimnaziala nr. 1 Rosia will pay the first installment within 30 days of signing the partnership agreement.

**Responsibilities and activities of the Beneficiary Istituto Comprensivo „D. Bramante ”:**

- Carrying out all activities (implementation, dissemination, evaluation) according to the project implementation plan;
- Organizing the mobility activities hosted according to the application form during October 2022;
- Ensuring the logistics necessary for the implementation of the hosted activities;
- Providing the coordinating organization with evidence regarding the dissemination of the project: pictures, scans, links to articles, films, etc.
- Providing materials / evidence of the activities for the Facebook page of the project;
- Compliance with the number of participants in mobility according to the application form: six students and two teachers per mobility;
- Using the budget only for expenses eligible for the project;
- Spending 100% of the allocated budget, with 20% to be transferred after the end of the project;
- Display the EU emblem in all dissemination activities;
- Attendance at monthly online project management meetings by contact person or another member of the project team;
- Respond to requests from the coordinating organization regarding any changes that may occur during the project;
- Promptly inform of any changes;
- Deliver an Europass Mobility or Certificate of participation for all the participants in the hosted mobility;
- Preparation and transmission to the coordinating organization of the activity report every six (6) months accompanied by the declaration of honour of the legal representative in which he explains in detail the degree of budget spending.

Three reports will be made as follows:

Activity report 1 – March 14 – September 13 2022: deadline September 30, 2022

Activity report 2 - September 14, 2022 - March 13, 2023 : deadline March 30, 2023

Activity report 3 - March 14 - September 13, 2023: deadline September 30, 2023

- In case of withdrawal or non-performance of the activities, fully refund the amounts received within the project;

**Additional information:**

- Beneficiaries must provide participants with the relevant privacy notice for the processing of their personal data before it is encrypted in the electronic management systems for Erasmus + mobility activities.
